7. Admission Procedure

- 1. Candidates must report for Institute Level Round as per schedule mentioned above.

- 3. Students will be admitted in the respective category against vacancies based on merit in the counseling round.
- 4. Admission will be done according to State Merit Number.
- 5. Selected candidates must secure admission immediately by submitting all required documents and fees.
- 6. All candidates must bring original documents and two photocopies for verification.
- 7. Payment of fees is through online mode or by cash at the admission portal.
- 8. Admission shall be confirmed only after document verification, submission of all original documents and fee payment.
